This fee does not include embalming, visitation or funeral ceremonies, or other goods such as a cremation urn. Minnesota law does not require you to purchase a casket for cremation. If you want to arrange a cremation, you can use a cremation container. A cremation container is a combustible, closed container that encases the body and can be made of materials like fiberboard or corrugated cardboard and into which a dead human body is placed prior to insertion into a cremation chamber for cremation. The containers we provide are: Basic Cardboard Cremation Container. FTC: If you want to arrange a direct cremation, you can use an Alternative Container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). Death Certificates are official documents issued by government authorities that record the details of a person's death. They are used for legal proof of death, settling estates, insurance claims, pension and social security, healthcare records, closing accounts and services, and for genealogy and historical records. Our \$50 fee covers our staff's time and effort in obtaining and sending your certificates and is charged once, no matter how many certificates you order. The state or county issuing the certificates sets its own per-certificate fee, which is billed in addition to our fee and scales with the number of certificates requested.
